#### 3rd District City Council

The 2015 3rd district primary race is one of our key focuses this year. The Fort Wayne Professional Firefighters Local 124 PAC Board interviewed both candidates. The PAC Board has identified the candidate we believe would provide the best qualities of leadership to the people of Fort Wayne & the 3rd district. The endorsed candidate has professed strong support for public safety, core services, neighborhood infrastructure and community outreach. ## Mark Stafford- (R)

Mark Stafford is a Republican running in the 3rd District. Mark has worked for the Parks and Recreation division in the City of Fort Wayne for 16 years and is a proud father of 5. He has been married to his wife for over 25 years, and is an active member in his church. He is advocating for strong communities, core services and restoring community infrastructure. He is a strong supporter and advocate of working families. Given a newly adopted state law that prohibits a municipal employee from holding an elected office while working in the City, Mark is prepared to leave his 16-year career with the City of Fort Wayne just for the opportunity to serve in a higher capacity.

#### 6th District City Council

### Glynn Hines- (D)

Glynn Hines is an incumbent for the 6th district council seat. He has held his seat on council since 1999. Along with strong support for his community and neighborhoods, Glynn has advocated and supported full staffing of the Fort Wayne Fire Department and core services. Glynn's focus is on neighborhood association empowerment, economic and business development, housing revitalization and new housing developments, public safety initiatives, and programs that focus on the youth, giving them positive alternatives to deviant behavior.

Glynn is married to Pamela Peterson-Hines. She is currently the Executive Director of the National Kidney Foundation of Northeast Indiana. They have been married since January 1, 1983 and have two daughters Monique and Candace. Monique blessed them with a grandson, Carlton Smith. Glynn also has two adult sons.

Educational background for Councilman Hines includes graduate of Central High School in Fort Wayne, B.S. degree with a double major in History and Speech & Drama from Manchester College, North Manchester, Indiana and graduate study at Temple University in Philadelphia, Pennsylvania.

Glynn was formerly employed by Bank One as Assistant Vice President and with Xerox Corporation as Marketing Manager. His political career began in 1977 with then 1st District City Councilman John Nuckols. He worked as precinct committeeman in the 1st District. Glynn also served as campaign manager for 1st District Councilman Archie Lunsey in 1991.

Glynn is an active community volunteer, serving on the boards of the State of Indiana Commission for Dr. Martin Luther King Jr. Holiday, the Knight Foundation, Directors for the Community Foundation of Greater Fort Wayne, Citi Link Public Transit, and advisor to the S.O.A.R. Housing CDC Board. Glynn also served on the boards of the United Way of Allen County, Fort Wayne Redevelopment Commission, Project Renew, NAACP, and the Gingerbread House

#### At Large City Council

The 2015 Council At-Large primary races are strongly contended by many qualified candidates. Mr. Armstrong is employed at Allen County Solid Waste and has been an At-Large member of the Allen County Council since 2009.
